



Election 2020 Voter Guide

In his October 4th Sunday morning message, Pastor Jimmy identified the three most important issues for Christians in choosing for whom to vote. While there are many other important issues to consider, this voter guide is based solely on those critical issues. For simplicity, candidates are identified by color code:

●	The candidate is opposed to Christian values in that area
●	The candidate has mixed, neutral, or unknown positions
●	The candidate agrees with Christian values on that issue.
●	Not enough information could be found to assess a position
“Endorsed” – a candidate we recommend for their biblical worldview positions	
“Preferred” – While clear information on life, marriage, and religious liberty could not be found, this candidate is preferred over his/her opponent for other reasons. There is no expectation that this candidate will vote/act biblically in all cases.	

Candidates’ actual positions and performance in these areas is much more complicated and nuanced than can be depicted this way, but we have chosen this method for the sake of simplicity.
